# Soil Management Contract



## Soil admission procedure

The information contained in the Soil Management Contract and the analyzes provided will be verified by a representative of SIGNATERRE ENVIRONNEMENT. If the information is correct, an authorization number will be issued by the SIGNATERRE ENVIRONNEMENT representative and transportation manifests will be sent to the client.

When the soil is received at SIGNATERRE ENVIRONNEMENT, a compliance validation of the soil profile will be made. Sampling according to the soil sampling guide method of the Quebec Expertise Center in Environmental Analysis will be carried out systematically for each project.

Following this sampling, the soils must conform with the declarations of this contract as well as the information recorded on the transport manifests, otherwise all or part of the soils will be billed or removed from the site according to the results of the control analyzes carried out by SIGNATERRE ENVIRONNEMENT. If soils are to be removed from the site, 30% of the amount will be retained to cover the analysis, administrative and handling costs.

When sending the transport manifests to the customer, instructions on their use are included. Authorization numbers on transportation manifests differ for each product listed in the bid. Soils will be managed and invoiced according to the transport manifests used. It is the customer's responsibility to:

Send instructions to the load manager on the use of the manifests.

Use manifests with the authorization number drawn to the loaded soil type.

SIGNATERRE ENVIRONNEMENT will not be liable due to the misuse of transport manifests.

### Billing

The invoiced prices will comply with the bid included in this contract, according to the shipping manifests used (the manifests authorization numbers differ for each product).

Invoices and vouchers are sent to the email address listed on the client's Account Opening form. They will also be sent to the project manager listed on this contract.

## **Soil Profile** (Declaration of the issuer)

#### Soils that can be admitted to the SIGNATERRE ENVIRONNEMENT site will have the following chemical and physical features:

- These soils contain 25% or less of residual materials;

- These soils do not contain any explosive or radioactive material within the meaning of Article 3 of the Regulation on Hazardous Materials (paragraphs Q-2, r.15.2);

- These soils contain no waste of biological origin;
- The pH of these soils is in the range of 3 to 14;

- In accordance with section 4.5 of the Regulation respecting the burial of contaminated soils. These soils do not contain free liquid.

#### For Technical Landfill:

- Soil contamination levels will be lower than the values in Schedule 1 of the Regulation respecting the burial of contaminated soils.

#### For the Treatment Centre:

- Soils do not contain pieces of asphalt or tar.
- Soils have a moisture content of 20% or less.
